## **THE RAJAB HILAAL** **THE DEBACLE OF THE JUHALA**

Since the Juhala and Mudhilleen of the bogus paper body 'uucsa', along with its conglomeration of jaahil affiliates, viz., the Hindu fire-god worshippers of the MJC, the Cross-worshippers of the NNB jamiat of Fordsburg and the Zig-Zag KZN Jamiat and similar other moronic paper bodies, stupidly feel thwarted in their nafsani objective of their hallucinated 'leadership' role, by the confirmation of the Rajab hilaal by GENUINE UUCSA and the Jamiatul Ulama of South Africa, they are struggling in their debacle of fitnah, causing unnecessary confusion in the bid to salvage what they believe is 'lost prestige' for their inability to announce the commencement of the month of Rajab for the simple reason that they had failed to sight the hilaal.

The reason for their dilemma of fitnah is that they are not guided by the Shariah. This clique of juhala molvis and sheikhs have the problem of dealing with their own lustful egos and their unattainable objective of leadership of the Muslim community of South Africa. In the insane pursuit for the attainment of these objectives which pave the pathway of Jahannam, they have totally lost their Imaani bearings, hence they stupidly and recklessly seek to please whomever they believe can assist them in the attainment of the mirages which they have set as their goals. They will therefore worship Hindu gods, become cross worshippers, curry favour with grave-worshippers and bootlick kuffaar politicians. Their stupidity is mind-boggling for claimants of ‘leadership’ and for men who purport to be Ulama and experts of the Shariah. The reality is that this conglomerate of juhala is lacking in the rudimentary *ahkaam* of Tahaarat and Salaat, hence they are experts in the art of creating disingenuous stratagems to kick up considerable smoke to blur Shar’i realities for the *Awaamun Naas (the laity)*.

While we, i.e. Genuine UUCSA, do not seek to impose our views, which include our confirmation of the Rajab hilaal, on others, this league of mudhilleen, of bogus and hybrid sheiks and quarter-baked molvis have absolutely no valid Shar’i basis for rejecting the validity of our confirmation of the Rajab Hilaal. What is their basis for denying the validity of the sighting accepted by us? We reiterate with emphasis that it is not Waajib for them to accept our announcement. But they should desist from their satanic ploys of causing unnecessary confusion and dissension in the community with their shaitaani innuendos to cast aspiration on the validity of the sighting and its confirmation and acceptance by us.

We are not the students and underlings of these juhala and bogus sheikh and molvi characters. They should not attempt to hoist their jahaalat on us or on the community. As far as we are concerned, all of them – the murtad MJC, the Cross-worshipping NNB jamiat of Fordsburg, and now their poodle, the Zig-Zag KZN Jamiat – are Islamically *person’a non grata*. If just one good woman reports that she has sighted the hilaal of Ramadhaan, then on the basis of her claim, Ramadhaan will be declared. The stupid ostentatious, westernized forms and rigmarole pertaining to the position, manner of the moon, moon orientation, etc., are stupidities uncalled for. There is no Qur’aanic and no Hadith substantiation for these superfluties.

The *adaalat* of the sighter is the determinant, not the stupid criteria disgorged by astronomers. These chaps should take admission at some Darul Uloom to study the

Kutub of Fiqh to enable them to understand the topics with which they are dealing and for which they deceptively portray expertise.
