THE SO-CALLED 'MUSLIM' MARRIAGES BILL – THE KUFR BILL WHICH IS NOT A MUSLIM PROPOSAL

COURT ORDERS EXTENSION OF CLOSING DATE

THE SOUTH GAUTENG HIGH COURT ON 11 March 2011 ordered that the closing date for comment on MMB which was originally 15 March 2011, be extended to 31 may 2011.

ALHAMDULILLAH! The application for extending the closing date made by Zehir Attorneys was successful.

All Muslims who have so far not lodged their objections against the Kufr MMB, are urged to fulfil their obligation to Islam to protect the Divine, Immutable Shariah of Allah Azza Wa Jal. Islam is under attack, not by the government, but by inimical, hypocritical and devious forces operating from within the shadows inside the Muslim community. They have become cogs in a despicable, pernicious plot to undermine the Shariah. They are entities and outfits with different, but dark agendas, worldly and nafsani.

Muslims should be alert and not fall into the trap of those who argue in favour of a measure the Kufr Bill) which mutilates and abrogates fundamental ahkaam (laws) of the Shariah. The Ummah is not in need of state interference to teach us our Deen and to impose on us kufr concepts, kufr rules and regulations in the name of Islam.

We call on all Muslims to dissociate from the Bill – to protest against the kufr Bill – to lodge their objections, thereby informing the government that we are not interested in MMB. The government has been misled by outfits such as MJC, NNB (No Name Brand Jamiat of Fordsburg) and the phantom paper body called UUCSA which has no significant support in the country.

The MJC primarily and perhaps exclusively is an outfit whose function has fossilized into the issuance of halaal certificates to 'halaalize' CARRION meat and chickens. The NNB Jamiat has a small support base among a section of its membership. UUCSA is a hallucinatory entity – the effect of the hallucination of MJC and NNB Jamiat. At UUCSA's last meeting, only two of its founder executive members attended. Incidentally they were MJC and the NNB Jamiat.
