Every year, Qur'baani time, there mushrooms a glut of 'Qur'baani' vendors, especially in the Transvaal (Gauteng, etc.) and Natal provinces. Ridiculously low prices are quoted for Qur'baani animals.

Most of these unknown vendors are frauds who capitalize on the gullibility and ignorance of the public. Muslims who support these frauds are also blameworthy. In order to soothe their conscience that they are discharging their Qur'baani obligation, they allow themselves to be hoodwinked by these crooks. The low prices are attractive bait for those who lack understanding of the meaning of Qur'baani.
