### SANHA'S CARRION LIES DEBUNKED

#### MAULANA ABDUL HAMID ISSUES A STERN WARNING TO THE LIARS

SANHA, in its desperation to redeem its ruined image and reputation – ruined by its carrion halaalization corruption – most audaciously claimed the following falsehood:

*“The Halaal poultry slaughter process at Rainbow and commercial abattoirs of the like was initiated and/or endorsed by Ulama Institutions and leading Islamic scholars of the past the likes of the marhoom Mufti Shafi r.a., Moulana Ansaari r.a., Moulana Omarjee r.a., Moulana Sema r.a., Mufti Ebrahim Sanjalvi r.a., Mufti Bashir Sanjalvi r.a., Moulana Yunus r.a., Mufti Ahmad Mia r.a. including many leading contemporary Ulama.”*

The brazen inclusion of the names of Mufti Ebrahim Sanjalvi (rahmatullah alayh) Mufti Bashir Sanjalvi and Mufti Ahmad Mia (rahmatullah alayh) is a desperate shot in the dark in the hope that no one would be wise enough to realize the blatant LIE uttered by the Carrion Vendor (SANHA).

The carrion chickens which SANHA and the MJC halaalize were not halaalized by the aforementioned Ulama, all of whom have departed from this world. SANHA was hoping that ‘dead men would not speak’, little understanding that associates of these Marhoom Ulama are still around, including ourselves who had participated with these Ulama in an inspection of the Rainbow carrion plant at Hammarsdale during the 1970s. The three Ulama of Mia’s Farm mentioned above had outrightly rejected the so-called ‘halaal’ status of Rainbow’s carrion.

The issue at this juncture is not the ‘halaal’ status conferred to the carrion by the Natal Ulama of that period. The issue is the LIE which SANHA has disgorged and scandalously attributed to the three senior Ulama who are today in Aalm-e-Barzakh.

Debunking this carrion falsehood of SANHA, Maulana Abdul Hamid Sahib, Principal of Darul Uloom Azaadville, made the following statement at the very recent Jalsah in Azaadville:

***“The most important thing is to follow in their footsteps (i.e. the footsteps of the three Ulama mentioned above). It is not proper for us to use their names for our benefit and to sell their names for this dunya’s benefit. They can fix bayaans and seminars whilst they do the opposite to what they (the senior Ulama) have taught us. This is making a mockery and like making a haraam. It is like being born to your father. You take his name, but depart from the ways he has taught you.***

***Deceiving the public! In this point I am going to become a bit emotional. Please forgive me. I have heard a few times (from certain quarters) that Mufti Sanjalvi Saheb (rahmatullah alayh) had sanctioned commercially cut chickens and had said that such chickens are halaal. THIS IS A TOTALLY BLATANT LIE. I was with the Jamiat (i.e. the***

***then Jamiatul Ulama of Transvaal of which Mufti Ebrahim Sanjalwi Sahib was the Ameer) very strong in those days. I was sent personally by Mufti Sahib for an inspection of various (chicken) plants.***

***Mufti (Ebrahim Sanjalwi) Sahib's final words were: "NOT (EVEN) ON MY DEAD BODY! IF YOU PEOPLE WANT TO CLASSIFY IT AS HALAAL, DO IT AFTER I HAVE DIED. BUT AS LONG AS I AM LIVING, I CAN NEVER SEE THESE THINGS (I.E. THE CARRION CHICKENS) BEING HALAAL."***

***So, people who are vying with Mufti Sahib and using his name so wrongly, saying that he had sanctioned (the carrion chickens), PLEASE FEAR ALLAH! FEAR THE DAY OF QIYAAMA! AND FEAR THE QABAR, PLEASE!"***

SANHA should heed this solemn warning and not ruin its Imaan and destroy its Aakhirah with its greed for money constraining it to halaalize haraam carrion, then attempting to justify its carrion with the appalling falsehood that senior Ulama who are no longer present with us had condoned the evil of carrion halaalization.

The skulduggery of SANHA in the use and misuse of the names of Mufti Ebrahim Sanjalwi, Mufti Bashir Sanjalwi and Mufti Ahmad Mia (rahmatullah alayhim) is absolutely scandalous. It testifies for the rotten, gutter-type groveling in sewerage drains to which SANHA has lowered itself in its sheer desperation to peddle the LIE of the carrion chickens of Rainbow, Early Bird, etc., etc., being 'halaal'.

We are now entering the Holy Month of Ramadhaan. Even a single morsel of haraam food ingested intentionally destroys all the benefits and rewards of the Fast, and invites the Wrath of Allah Ta'ala. Muslims should exercise extreme caution, especially during the month of Ramadhaan. The spiritual treasures available during this glorious Month should not be destroyed with carrion chickens, haraam food and listening to the haraam programs disgorged by the Devil's radio stations which pollute the sanctity of Ramadhaan and of the auspicious Nights of this Mubaarak Month.

These haraam carrion chickens which SANHA, MJC, NIHT, ICSA and other carrion vendors are halaalizing are spiritually fatal poison, and physically ruinous. Haraam carrion chickens cause spiritual and physical cancer and a host of other diseases – both spiritual and physical. It does not behove People of Imaan to degenerate to the level of vultures for consuming the halaalized filth. In fact according to the Shariah it is haraam to feed even dogs with the carrion filth halaalized by these Carrion Vendors. The Qur'aan Majeed issues the following warning regarding food fit for Muslim consumption:

***"O People! Eat from the earth what is halaal and tayyib, and do not follow in the footsteps of shaitaan ( by eating haraam filth). Verily, he (shaitaan) is your open enemy. Verily, he instructs with only evil and immorality and that you fabricate about Allah what you know not."***
