NEW LAWS OF KUFR OF THE SAUDI REGIME

In its insane pursuit to placate its U.S.A. master and protector, the Saudi regime has now descended into the dregs of flagrant kufr with its new initiative of abrogating explicit commands of the Qur'aan Shareef and of the *Ahkaam* substantiated by fourteen centuries of *Ijma'* of the Ummah. Among the kufr which the Saudi regime is introducing are:

* The minimum age of marital consent will be 18 years. This kufr cancels the Shariah's minimum age of *buloogh* which is not later than 15 years. A girl of 17 years will not be allowed to marry even if she has the consent of her Wali. Only if the Saudi kaa
fir c
ourt grants permission will she be able to enter into Nikah which is her right conferred to her by Allah Ta'ala.

* The new law of kufr abortively attempts to achieve equality between men and women in flagrant rejection of the Qur'aan and Sunnah.

* The new Kufr measure will cancel the man's right of *Qiwaam'* (Absolute Rulership) conferred to him by the Qur'aan Hakeem. This is the worst aspect of kufr of the Yahudi Saudi kufr regime. In this regard, the liberal, Faasiq
Saudi Gazette,
states:

"The sources said the law would cancel the right of guardianship for men over women except in marriages, where Islamic Shariah gives them this right."

The Shariah does not restrict the man's (father's/husband's) right of guardianship to only marriage. In all aspects of life, the man (father/husband) is the supreme head and it is his incumbent obligation to ensure that the females under his jurisdiction comply with the Shariah in all departments of life. There are deluges and mountains of Qur'aanic and Sunnah evidence to conclusively back up this claim and to relegate the Saudi regime into the Hell of Kufr for so vilely and flagrantly cancelling Allah's Laws with American-dictated Kufr.

* The *Saudi Gazette* further reports: "According to the sources, the new law has described the relationship between married couples to be a partnership, not *qiwaamah* (supremacy of men over women) as it used to be."

This haraam new law is in diametric conflict with the Shariah's Law as commanded in the Sunnah and the following Qur'aanic aayat:

"Men are the Rulers over women by virtue of the supremacy which Allah has bestowed to some (i.e. to men) over others (i.e. women) and by virtue of the wealth which they spend (to maintain women)."

(Aayat 34, Surah Nisaa')

Emphasizing the superiority of men, the Qur'aan states: "And for men there is a rank over women." (Aayat 228, Baqarah) There are innumerable Ahaadith elaborating the superiority of men over women. Substantiated by *Dalaa-il Qat'iyyah* of the Qur'aan, Ahaadith and *Ijma'*

of all authorities of all Math-habs, rejection of this explicit Qur'aanic command is flagrant kufr which expels the Saudi regime (the king and his corrupt henchmen) from the fold of Islam.

Qawwaam appearing in the aforementioned aayat, *Qayyaam* and *Qayyim* is a person who is an overseer or an administrator of affairs. It is for this reason that the Mufasssireen have translated this term in the Aayat to mean

Haakim (Ruler).

That is, men are the rulers of women. Every organization requires a head to oversee and supervise its activities. The same applies to the home organization. Allah Ta'ala has appointed the man to be the head and ruler of the home domain. Just as it is impossible for a country to operate without a ruler, so too, is it impossible for the home to function smoothly without a head, and the Qur'aan has appointed the man the head and ruler of the home. And, this is Allah's Law which the kufr Saudi regime has decided to abrogate.

While this rulership conferred to the man is not unbridled supremacy, but is subjected to Shar'i constraints, this is not the occasion to delve into its exposition. In this article the concern is to highlight the kufr of the Saudi regime which comes within the full glare of the Qur'aanic aayat:

“Those who do not rule according to that (Shariah) which Allah has revealed, verily they are the kaafiroon.”

(Aayat 44, Maaidah)

Presenting the *tafseer* of Aayat 34 Surah Nisaa', Ibn Katheer states: *“Allah Ta'ala states: ‘Men are the Rulers over women...’, i.e. The man is the ruler over woman He is her head (chief), her senior and the haakim (ruler) over her, and her reformer when she is disobedient. Because, verily, men are superior to women, and the man is better than the woman. For this very reason only men were the repositories of Nubuwwat. Similarly, being the ruler of the country is the office of solely men because Rasulullah (sallallahu alayhi wasallam) said: “Never will prosper a nation who assigns its affair to a woman.” Narrated by Bukhaari from the Hadith of Abdur Rahmaan Bin Abi Baqrah from his father. Similarly, is the post of the Qaadhi (i.e. it is solely for men), etc. “*

All the hundreds of Tafseer, Hadith and Fiqh kutub are unanimous in this *tafseer*. The Saudi

regime is perpetrating incorrigible kufr for flagrantly embarking on a path whose ultimate objective is the total transmogrification of the Shariah, i.e. in effect it is the displacement of the Shariah of Muhammadur Rasulullah (sallallahu alayhi wasallam) in the same way that the Yahood and Nasaara have mutilated, cancelled and displaced the Shariats of Nabi Musa (alayhis salaam) and Nabi Isa (alayhis salaam). However, since Allah Ta'ala has given the assurance in the Qur'aan, that the kuffaar will never succeed in the nefarious plot to extinguish the Shariah, the Saudi imbeciles will miserably fail in the long term. In this regard the Qur'aan Majeed states:

“Verily, We have revealed the Thikr (the Deen), and most assuredly We are its Protectors.”

“They the kuffaar – the Saudi regime in this case) plot to extinguish The Noor (the Deen) of Allah whilst Allah intends to complete (and perfect) His Noor even though the kaafiroon abhor it.”

The very evil forces whom the Saudi regime is appeasing with its kufr, will engineer the demise of the Saudi king and his regime. Although the Saudi move of Kufr is extremely lamentable, it is not surprising. We are in an age called *Aakhiruz Zamaan* which is in close proximity to Qiyaamah. One of the Proofs of Nubuwwat is the truth of the predictions of the Nabi (sallallahu alayhi wasallam). Among Rasulullah's predictions is that women in the region today called Saudi Arabia, will maniacally gyrate around idols with their 'buttocks' swaying. *(Note, the term 'buttocks' has been mentioned by Rasulullah – sallallahu alayhi wasallam).* The Saudi regime is setting the stage for the shirk of idolatry. Fisq, Fujoor and Kufr are the presage for the ultimate introduction of idolatry.

The Ulama from different countries who enjoy the favour of the Saudi regime which provides them with perks – free Umrah tickets, visas, accommodation, etc. – have the Waajib obligation to admonish their Saudi patrons – to draw their attention to the evil direction in which the Saudi regime is headed. Silence for the fear of being denied these perks will confirm the 'Scholars for Dollars' status of these scholars who have become signs of Qiyaamah, for the Hadith informs us that the time will dawn when *“the dunya will be pursued with the amal (deeds) of the Aakhirah.”* Knowledge which is supposed to be employed for the acquisition of Allah's Pleasure, is today most despicably utilized to gain the favour of corrupt and degenerate rulers and men of wealth.

THE MPL (MUSLIM PERSONAL LAW) PLOT

The current law of kufr being introduced by the Saudi regime pertains to the ubiquitous MPL conspiracy plotted decades ago in the West to undermine the Shariah by imposing on Muslims kufr under the guise of the Shariah. The MPL has been imposed on Muslim communities in almost all Muslim countries. It is a common thread of kufr running through all Muslim lands, and now Saudi Arabia has been ensnared in this kufr trap.

The very same MPL plot in the form of the MMB (Muslim Marriages Bill) is the subject of intense debate in South Africa. Zindeeq and Munaafiq stupid secular lawyers, stupid university professors, stupid sheikhs and stupid molvis – the scholars for dollars, are the hirelings of the plotters. They are the cogs in the MPL conspiracy, being manipulated by the West to destroy Islam and to subject the Shariah to the same treatment meted out to the Shariats of the previous Ambiya (alayhimus salaam).

INTERFAITH

The other extremely dangerous plot of kufr engineered by the West is the kufr interfaith religion whose leadership has been entrusted to the Saudi regime which funds and promotes this kufr. It appears that the Saudi king is playing the role of Attaturk who had kufriized Turkey. The same process is being incrementally introduced in Saudi Arabia. Warning Muslims to be on guard against these enemies of Islam which include the conglomerate of zindeeqs and munaafiqs masquerading as Muslims, the Qur'aan Majeed states:

“O People of Imaan! Do not take as a confidant anyone besides yourselves. They (the kuffaar) will leave no stone unturned to ruin you. They wish for that which will cause suffering to you.

Verily, hatred (for you) has gushed forth from their mouths. But What their hearts conceal is worse. Verily, We have explained clearly to you the aayaat, if indeed you are able to understand.”
