SANHA'S BCCSA KUFR ACTION DISMISSED

SANHA'S RENEWED ATTEMPT TO SEEK KUFR 'JUSTICE'

"O MY RABB! VERILY, MY NATION HAD MADE THIS QUR'AAN AN OBJECT OF REBUFF."

(AAYAT 30, FURQAAN)

This will be Rasulullah's lament on the Day of Qiyaamah when the criminals who had rebuffed the Law of the Qur'aan will be hauled in the Divine Court. In our midst there is the unholy trinity –SANHA, NNB Jamiat of Fordsburg and Radio Shaitaan (the so-called radio Islam) which comes squarely within the purview of this Qur'aanic Aayat. This unholy trinity constitutes a massive deception. This triumvirate, whilst masquerading as 'Ulama' and Propagators of the Deen, is the very antithesis of the Deen. It trumpets in the name of the Deen whilst seeking kuffaar and secular mechanisms to resolve its imaginary disputes.

In November 2013 SANHA had applied to the BCCSA (Broadcasting Complaints Commission of South Africa) – a type of a court appointed by the government – to chastise Mufti A.K.Hoosen whom SANHA accused of having disrespected its chairman, the Qalb, Mr.Yusuf Patel who lamentably happens to be a student of Mufti A.K.Hoosen. This ungrateful Qalb has and is shamelessly aiding and abetting SANHA in its haraam dastardly attempt to humiliate Mufti A.K.Hoosen in the secular BCCSA court. The BCCSA has now dismissed and thrown out SANHA's complaint. SANHA had searched for izzat and succour from this non-Muslim forum, but has lost its case.

It is essential to highlight that SANHA's failure to achieve its objective in the secular kuffaar forum which it had petitioned in flagrant violation and rejection of the Qur'aan-e-Hakeem, is no cause for gloating. On the contrary, there is real cause for eternal lament. SANHA and the NNB Jamiat, despite presenting themselves as 'ulama', acted in flagrant violation of Allah's Commanded sounded in the following Qur'aanic verses:

□ **"And, if two groups among the Mu'mineen fight, then (O Community of Muslimeen!) establish peace between them. Then, if one of the groups commits excess (injustice) on the other, then (all of you) fight that group which has transgressed until it returns to the Command of Allah."** □ (Aayat 9, Surah Al-Hujuraat)

□□□□ **"Verily, the Mu'minoon are Brothers. Therefore establish peace between your Brothers (the two □ fighting groups) and fear Allah so that Rahmat (Mercy) □ be bestowed to you."**

(Aayat 10, Surah Al-Hujuraat)

Read these two aayats in conjunction with the aayat cited at the beginning of this Naseehat to understand the kufr of the unholy trinity which has rejected and rebuffed Allah's Command in SANHA's name. Allah Ta'ala imposes on the Muslim community the obligation of resolving their mutual disputes in accordance with the Shariah within the confines of Islamic forums governed by the Shariah. It is absolutely ludicrous and Islamically mind boggling to behold a group professing to be Ulama, but resorting to bootlicking of a non-Muslim secular institution in its crazed and malicious desire to chastise and bring disgrace on another Aalim who has proclaimed the Haqq regardless of his methodology of proclamation.

The Qur'aan Majeed commands that disputes be resolved by Muslims themselves, and the basis on which the resolution must incumbently take place is the Shariah. Thus the Qur'aan Majeed states: "We have established you on a Shariah regarding (all your) affairs. Therefore, follow it, and do not follow the vain desires of those who know not." The Qur'aan, in the aforementioned two Aayats of Surah Hujuraat explicitly and emphatically commands internal resolution of mutual disputes, that is: It is haraam for Muslims to resort to kuffaar institutions, tribunals and courts to resolve their differences. Does SANHA's/NNB's miserable so-called 'ulama' feel no shame and no inhibition for their flagrant rejection of the Qur'aan and for their bootlicking of the non-Muslim secular BCCSA forum? The reality is that SANHA is not interested in an amicable, Islamic resolution. It has rebelliously rebuffed the Qur'aanic Command of internal (Muslim) mediation for seeking relief or for resolving its imaginary dispute. The haraam monetary stake is high. Driven by enmity, malice and some sinister agenda, SANHA is satanically and intransigently continuing with its effort to seek relief from the secular BCCSA, and a necessarily corollary of such haraam relief is the inordinate craving to humiliate Mufti A.K.Hoosen.

Although SANHA's case has been dismissed by the BCCSA, SANHA has now again instituted the same haraam action in a more determined fashion. This conglomerate of ulama-e-soo' – the unholy trinity consisting of the SANHA-NNB Jamiat-Radio Shaitaan triumvirate – has now engaged attorneys to renew the haraam action. Presenting its self-same baseless complaint in another form, SANHA is now bringing the action against the service provider, Multichoice and Channel Islam Broadcasting. These are the two institutions against whom SANHA's complaint in its supplementary complaint is directed. Nevertheless, the entire attack of SANHA even in its supplementary complaint is directed at Mufti A.K.Hoosen. SANHA will have to pay tens of thousands of rands or hundreds of thousands of rands in fees, depending on the trajectory of the case which Channel Islam will undoubtedly be constrained to oppose. No miserable molvi of the unholy trinity will dig in his personal pockets to fork out the huge amount for the haraam fees in the wake of the haraam action in the kuffaar institute. The Ummah's Lillah/Sadqah/Zakaat funds will be squandered in the frenzy to extract vengeance. But, this triumvirate sitting with millions of rands of the Ummah's undischarged Zakaat and Lillah obligations, cannot be concerned about this haraam aspect. The Ummah's millions of rands are lying idly in the coffers of the ulama-e-soo', hence may be utilized at whim and will for the haraam SANHA action.

A perusal of SANHA's supplementary complaint document establishes that this unholy trinity has absolutely no valid case in terms of the Shariah. It is this realization that has driven SANHA to seek relief in a secular non-Muslim forum (BCCSA) in terms of the law of jaahiliyyah about which the Qur'aan Majeed says: "What! Are you searching by them (by the BCCSA) Izzat (honour and respect)? Verily Izzat belongs to Allah." "What! Are you searching for the law of jaahiliyyah?"

We reiterate that it is indeed mind boggling from the Islamic angle to contemplate that a Qalb (an ungrateful, unfaithful student) is shamelessly striving in a kaafir court to humiliate his Ustaad, viz., Mufti A.K.Hoosen. Have enmity and malice blinded their already corrupt spiritual vision and effaced their Imaani conscience to flagrantly reject the Qur'aan's Commands? Yes, this appears too be their fate: "They are deaf dumb and blind, hence they will not return (to the Path of Hidaayat and Najaat)." – Qur'aan

When SANHA/NNB Jamiat has miserably failed to understand basic Imaani issues, what can be expected of them regarding Fiqhi masaa-il? One of SANHA's complaints in its Supplementary Complaint is the demand to be given the right to air its haraam carrion chicken views on the radio station from whence Mufti A.K.Hoosen broadcasts. Assuming that Mufti A.K.Hoosen had truly insulted and wronged SANHA, it does not give it (SANHA) the Shar'i right to demand to be allowed time to speak on a radio station which does not belong to it notwithstanding the existence of such a haraam 'right' in the rules of the BCCSA. SANHA does not have the Shar'i right to demand the right of invasion into another's domain/property.

SANHA has its own radio shaitaan on which it regularly airs its carrion views. There are other ways and means open to SANHA for disseminating its carrion and kufr views and pronouncements. It has no Shar'i right to intrude and trespass on another's property and domain. This demand by SANHA is by itself a haraam issue. The move to stifle the Haqq with the aid of the kuffaar court and laws of kufr illustrates the extremely low and degenerate level to which SANHA/NNB Jamiat has sunk. They are literally grovelling like sewer rats in sewerage drains in their insane frenzy to sustain their utterly destroyed reputation which had all along been propped up by falsehood and blatant lies pertaining to the Haraam carrion chickens.

These miserable 'ulama-e-soo' should not labour under any misconception should the kaafir forum decree in their favour. It will be no victory. On the contrary, it will only make manifest their villainy and confirm their kufr – the kufr of having flagrantly rejected the Qur'aanic command and prescription for resolving disputes. We should also add that in terms of the Shariah, there is no dispute here. Mufti A.K.Hoosen had correctly proclaimed Rainbow Chickens to be HARAAM CARRION. This is not only his right. It is his Shar'i obligation to alert the Muslim community and to warn them of the dire consequences of consuming the filth of haraam, diseased carrion chickens which SANHA/NNB Jamiat halaalizes. A hollow haraam victory achieved in a kaafir tribunal will not be able to stifle and extinguish the Haqq. The Haqq will always surface and predominate. Baatil must and will be defeated.
