Comment

Rasulullah (Sallallahu alayhi wasallam) said that it is not lawful for a woman who believes in Allah and the Last Day to travel a distance of three days (i.e. the *safar* distance) WITHOUT A MAHRAM. Thus, women who go on journeys without their mahram males are like *kaafiraat*, *khabeethaat* and *faajiraat*. They are immoral having the tendencies of prostitutes.

The organization which organizes such blatantly haraam female journeys of fisq and fujoor are following in the footsteps of Iblees. They are Agents of Shaitaan. It is vital to understand that it is haraam and even kufr to pursue noble ends with haraam methods. Ways and means which Allah Ta'ala has made haraam may not be employed to achieve objectives of the Shariah.

Washing garments with urine is haraam despite the urine removing the external dirt and grime. But the impurity of the garment is intensified.

What this shaitaani organization is doing is to promote the plot of Iblees.
