THE MJC – SHIAH NEXUS

IT IS THE HARAAM BOODLE!

Question: Are Shiahs Muslims? I am from Cape Town. I have tried to get an answer for this important question from the Muslim Judicial Council (MJC), but in vain. Despite several e-mails to the MJC, my question has not been answered. Five weeks after I wrote to the MJC, they very cagely responded: "I suggest you listen to an audio series on Shiasm by our previous Mufti, Mln Taha Karan. Fatwa Admin." Why can't they respond to my simple question? Why refer me to a dead man?

Not even the name of the sheikh/moulana who provided this wholly inadequate response is mentioned in the e-mail from the MJC's 'fatwa department'.

Please inform me without fence-sitting: Are Shiahs Muslims or do they belong to the KUFFAAR?

ANSWER

The MJC has become an agent of Dajjaal and Iblees. They are supposedly a cartel of ulama, yet they refuse to answer a simple question. The reason for their refusal is not a conundrum. From their perspective, they are constrained to conceal the Haqq thereby bringing themselves within the purview of the Qur'aanic command:

"Do not trade My Aayaat for a miserable price, and fear only Me. And, do not confuse the Haqq with baatil nor conceal the Haqq whilst you are aware." (Al-Baqarah)

The MJC is fully aware that Shiahs are KUFFAAR. They know this fact and reality better than they know their own sons and daughters. But the determinant in this scenario of concealing and confusing the Haqq is the

haraam boodle. It is Shiah money which has welded the lips of the MJC clique of *hufaalah* (rubbish) sheikhs and molvis. Not so long ago, the MJC had adopted the commendable stance of Haqq – the Haqq of opposing the Shiahs. The MJC had recognized the danger to Imaan posed by the “*Shia ideology*”.
