Halāl Status of Crystal Valley UHT Full Cream Milk, Poland

On verification of the halāl status of the imported **Crystal Valley UHT Full Cream Milk**, the MJC Halaal Trust (MJCHT) received a clarifying statement/letter on the 1st of July 2015, from Ms N. Sewnath, the QC of MONTEAGLE Consumer Group Limited, South Africa.

The letter clearly states that the **Crystal Valley UHT Full Cream Milk** is **not halāl** and that this information was corroborated by Ms N. Sewnath with the factory in Poland.

On further enquiry, the MJCHT obtained the Spec Sheet Q&A re: the imported **Crystal Valley UHT Full Cream Milk**. For ease of reference find below an excerpt of the Spec Sheet Q&A.

Product Name	Crystal Valley UHT Full Cream Milk
Product Description	Milk of Defined Fat Content, UHT treated and aseptically packed in cardboard packaging
Country of Origin	Poland
Is the Product Halal, or Produced in a Halal Approved Facility?	No

On the basis of the above-mentioned facts, the MJC Halaal Trust (MJCHT), as a Halāl Certifying Authority in South Africa, hereby declares that **Crystal Valley UHT Full Cream Long Life Milk, Poland**

- ❖ Is **not** halāl certified
- ❖ Its halāl status **could not** be confirmed

The MJC Halaal Trust (MJCHT) therefore advises the Muslim consumers to refrain from consuming **Crystal Valley UHT Full Cream Long Life Milk** that is duly imported from **Poland**.
