THE HARAAM, BOOTLICKING DECEPTIVE 'DAWAH' CIRCUS OF THE EVIL MOLVIS

QUESTION

On Cii this morning (23 July 2016), Ml. Mkhize advised Muslim ladies NOT to come to the Nkandla event dressed in black garb because in Zulu culture it is a sign of mourning. Was it a fair advice in terms of the Shariah?

ANSWER

Any Muslim whose intelligence is not deranged with fisq, fujoor and kufr understands that the advice proffered over Channel Shaitaan by the molvi is haraam bunkum.

The event at Nkandla is a merrymaking function dotted and adorned with haraam practices which the ulama-e-soo' are passing off as 'islamic' in the name of 'dawah'. But in reality there is no genuine Da'wah at this haraam circus. On the contrary, the non-Muslims will be presenting their 'dawah' of cultural shirk and kufr rites which the vile molvis and the stupid Muslim participants will have to swallow with respect and honour thereby compromising their own Imaan.

Besides the issue of black female dress, the very presence of Muslim women at this public funfare with its paraphernalia of haraam, fisq, fujoor, kufr and shirk factors and activities, is a major sin. When women are not allowed to attend even the Musjid for Fardh Salaat, then by what stretch of Imaani intelligence will it ever be permissible for them to attend a kuffaar funfare function at which everything from beginning to end is haraam? Cattle-slaughtering is a special rite of shirk and the worship of dead spirits.

Only such 'muslim' women will attend this function who are prostitutes at heart, hence they have no shame and no qualms for participating in an event which violates every law of Allah's Shariah.

Shaitaan has indeed urinated in the brains of these villain molvis and juhala sheikhs who are unable to distinguish between halaal and haraam, Imaan and kufr/shirk. Their *jahaalat* is absolutely mind boggling. If their problem was simple *jahaalat*, it could possibly have mitigated their villainy and evil participation. But the molvis who are promoting this haraam event – the molvis of the NNB Jamiat of Fordsburg, the molvis of Jamiat KZN, the molvis of Darush Shaitaan (deceptively advertised as 'darul ihsan), and the molvis of the Grave-Worshipping sect – are shaitaan incarnate. They are the agents of Iblees. They are shayaateen in human form.

Shaitaan has employed these incorrigibly evil molvis to undermine Islam and to mislead the ignorant masses, and to pave the path of Jahannam for them. Islam's fair name is being dragged in the mud of humiliation, shirk and baatil at this super shaitaani event of fisq, fujoor and kufr.

While we lament and criticize these foul followers and agents of Iblees, we have to intelligently understand that Rasulullah (Sallallahu alayhi wasallam) had, fourteen centuries ago, predicted this type of shaitaani enactments by the ulama-e-soo'. Thus, the People of Haqq should not become despondent in consequence of the rapid rise of fitnah, fisq, fujoor, kufr and shirk authored by those who proclaim themselves as 'scholars' of Islam. They are scholars for dollars whose profession is to undermine Islam. May Allah Ta'ala save the ignorant masses from the vile and filthy tentacles of these molvis who are operating their shaitaani trade from 'Jamiatul Ulama' platforms. But today, the Jamiats, especially the NNB Jamiat and Jamiat KZN, have become the jamiats of Shaitaan. They promote only *dhalaal*, *fisq*, *fujoor* and *haraam*. The smattering of so-called 'deeni' activities which they advertise, is the product of their *nafsaani riya*, *hubb-e-jaah* and *hubb-e-maal*. It is the only way in which they stay in business to fill their bellies with haraam salaries' which they misappropriate from Lillah and Zakaat funds which they siphon from a stupid public. Qiyaamah cannot be in the too distant future.
