## **KUFFAAR COURT CONFIRMS THE KUFR OF BOGUS ‘UUCSA’**

In a truly remarkable assessment of the objective for which the satanic BOGUS ‘uucsa’ was formed, the judge of the Pretoria High Court states in his judgment:

**“16. One of the primary incentives for the formation of the applicant was what the grouping now represented by the applicant regarded as the opportunity presented by the advent of the secular democratic era in South Africa. This grouping took the view that the time was propitious to advocate for the adaption of certain aspects of Islamic secular tradition by secular legislation. This would inevitably mean that secular constitutional outcomes would prevail in certain spheres over those outcomes which had previously been produced”.**

A salubrious and extremely pertinent and beneficial effect for the Muslim community in the outcome of the litigation initiated in the kuffaar court by BOGUS ‘uucsa’, is the revelation and exposure of its true shaitani objective which the judge stated in the above statement. In their papers, the *Zanaadaqah* (kaafir heretics) of the NNB jamiat (NO NAME BRAND jamiat of Fordsburg) under the pejorative epithet, BOGUS ‘uucsa’, have been compelled to reveal their true colours in their bid to silence the Haqq of genuine UUCSA.

It is essential for the Muslim community to understand that the clique heading currently the NNB jamiat (No Name Brand jamiat of Fordsburg), are *Bughaat* (*treacherous treasonists and rebels*) in terms of the Shariah. The logical consequence of this kufr motive, as correctly observed by the judge of the kuffaar court, is:

***“This would inevitably mean that secular constitutional outcomes would prevail in certain spheres over those outcomes which had previously been produced”.***

In simple terms for the better understanding of the Ummah, this means that BOGUS ‘uucsa’ has all along been covertly attempting to render the Shariah (the Qur’aan and the Sunnah) subservient and submissive to the kufr secular constitution of the country. This primary motive of *shaitaaniyat* and *baghaawat* is palpably demonstrated in almost every provision of the kufr MMB (the so-called ‘Muslim’ marriages bill) which the treasonists (*Bughaat*) were hell-bent on having enacted as legislation. But Allah Ta’ala has thwarted them by inspiring the kuffaar rulers to shelve the kufr measure initiated by the *Zanaadaqah* and *Munaafiqeen* operating in the guise of the NNB Jamiat and BOGUS ‘uucsa’.

They are a pernicious cabal of Satanists in human form at pains to undermine and dismantle the Shariah from within. Just recently one of their zindeeq compatriots stated to a lawyer in Durban: “*Contamination of the Shariah is inevitable.*” The moron lawyer who made this statement is a total jaahil, hence he has failed to understand that Allah Azza Wa Jal Himself has undertaken the responsibility to guard his immutable Shariah. All the efforts of the *Zanaadaqah*, *Munaafiqeen*, *Murtaddeen* and *Bughaat* masquerading as Muslims will miserably fail. They will lay rotting at the wayside with their shaitaani conspiracy to undermine the Shariah of Allah Azza Wa Jal.
