As AM we engage AIH in terms of section 157(1)(c) of the companies act 71 of 2008.

We have been duly advised by the AIH board of directors that our members are not the only ones seeking disinvestment and many other shareholders also want to disinvest. The company is on record saying that it wishes to serve the interests of all investors and hence we deem it appropriate to canvass the views of all investors on their continued investment. Findings and feedback will be presented to AIH.

Our position on disinvestment is, those who wish to disinvest must be allowed to do so unconditionally at a just and equitable price. **(NAV Per Share)** Net Asset Value per share is determined by totaling the assets less liabilities divided by number of issued shares.
